The Government of Pakistan has received a loan (Credit No. 6243-PK) from the International Development Association (IDA) for funding of Punjab Cities Program (PCP) and intends to use part of the funds to cover eligible payments under the contract for sub-project mentioned below. The Program will be implemented under the control of Punjab Municipal Development Fund Company (PMDFC). The Bidding is open to all eligible bidders in line with PPRA Rules.

Bidding Documents will be available immediately after publication of this notice and can be purchased from Office of Chief Officer, Municipal Corporation Kamoke for a non-refundable fee of Rs. 5,000/- for each set. Interested bidders may obtain further information (including the qualification criteria) from the same address.

4. Bids shall be valid for a period of 90-days after Bid opening and must be accompanied by bid security of amount mentioned above in the form of a Bank Draft or an irrevocable encashable on-demand Bank Call Deposit in favour of Chief Officer Municipal Corporation Kamoke and shall be issued on or before 9-05-2020 at 03.00 p.m. A pre-bid meeting with contractors will be held on 04-05-2020 at 02:00 PM in the office of the Municipal Corporation, Kamoke and interested bidders are invited for participation. The bids shall be received upto 12-05-2020 at 02:00 PM and opened in the presence of the bidders or their authorized representatives who choose to attend at 02:30 pm on the same day at the above given venue.

5. The Bidding Procedure will be governed by Rule 38(2)a of PPRA, 2014 "Single Stage Two Envelopes" procedure wherein the bidders will be required to submit Technical & Financial Bids in separate envelopes properly marked and both sealed in one envelop. The Technical Bids shall be evaluated on the basis of qualification criteria provided in the bidding documents. The bidders are required to include the letter of awards and the completion certificate of the similar works completed by them or in hand presently in the Technical Bid along with other qualification information asked for in the bidding documents along with documentary evidence. This information shall be used to establish whether the bidder is qualified to perform the work or not. The Financial Bids of only those bidders will be opened who qualify in the Technical Bids.

6. Bids are required to be submitted on item rate basis. The rates including G.S.T. and amounts in words must be filled by the bidder for each item in the Bill of Quantities and quote the total price.
